Bepin Choudhury Sees the Docto and his Leaving for Hudroo Falls




The story makes certain comments about the changing faces of friends. Discuss.

Bepin Choudhury on the other hand proves to be unhelpful and inconsiderate, something that greatly disturbs Chunilal.



Bepin Choudhury is aware of Dinesh Mukherji's sarcasm, yet Dinesh Mukherji comes across as a good acquaintance of Bepin Choudhury. However, by the end of the story, it is amply clear that Dinesh Mukherji functioned more as an ally of Chunilal, that as a friend of Bepin Babu. Chunilal also mirrors Bepin Choudhury's coldness by playing a prank on BepinBabu that unnerves him completely.

Unlike a friend, Chuni-Ial too becomes inconsiderable of the affect that his prank was having on BepinBabu's health.
